We write, subject to the qualifications stated below, in relation to the petition filed by Greenpeace Southeast Asia (Philippines) et al. against the respondents in the above-referenced case, which includes Eni S.p.A ("Eni"), with the office of the Commission on Human Rights of the Philippines.

We wish to respectfully inform the Honorable Commission that ENI is a foreign corporation organized and existing under Italian law. It operates in 69 different countries with more than 33,000 employees. It has no subsidiaries and/or branches in the Philippines. ENI does not do business in the Philippines.

Over the past 10 years, Eni's integrated strategy to transition towards a low-carbon energy future has allowed it to achieve significant results in terms of reducing process flaring and carbon intensity through reducing and offsetting greenhouse gas (GHG) emissions. Further significant results will be achieved in the next years thanks to our GHG Action Plan at 2025. Thanks to its proactivity Eni has been awarded a position on the CDP- Climate A List, which includes companies that have achieved the highest rating (A) following the independent evaluation of performance and strategies in response to climate change. Eni is the only oil & gas major that has achieved this recognition. ²

In addition to its presently low-carbon portfolio rich in natural gas resources, Eni has a commitment to renewables. It increased its investment in downstream green conversions and renewables and R&D in innovative renewable sources. In 2015, it set up a new business line called Energy Solutions that aims to complement and supplement traditional sources of energy with production from renewable resources.3

Eni plays a leading role in many important partnerships aimed at defining concrete short and long-term solutions for the transition towards a low-carbon energy future, such as the Oil & Gas Climate Initiative, Global Gas Flaring Reduction Partnership, Climate & Clean Air Coalition Oil & Gas Methane Partnership, Carbon Pricing Leadership Coalition, International Emissions Trading Association, the United Nations Global Compact Caring for Climate, IPIECA and the Task Force on Climate-related Financial Disclosures of the Financial Stability Board. It also joined the Paris Pledge for Action to demonstrate its commitment to the adoption of clear rules in line with the objectives of the Paris Agreement adopted on December 12, 2015 (COP 21). 4

This letter is being submitted ad cautelam, without submitting to the jurisdiction of this Commission or asking for any affirmative relief, since the Honorable Commission does not have jurisdiction over Eni and the subject matter of the petition of Greenpeace et al., among others. Eni reserves all its rights and remedies under all relevant laws and conventions.
